| Definitions  |  |
| Affiliates   | Companies related by common ownership or control. They can be financial and nonfinancial companies.  • ARTISANS' BANK has no affiliates.   |
| Nonaffiliates  | Companies not related by common ownership or control. They can be financial and nonfinancial companies.  • ARTISANS' BANK does not share with nonaffiliates so they can market to you.   |
| Joint Marketing  | A formal agreement between nonaffiliated financial companies that together market financial products or services to you.  • Our joint marketing partners include financial credit card, non FDIC insured investment product providers, education providers, and other third-party financial service providers. |
